DEFINITIONS

The following definitions are subject to any applicable grammatical conjugation according to the English language:

VAIN VILLAIN — the company VAIN VILLAIN, with its registered office located in the Netherlands.

Client or You — person who has placed an *Order* through the *Site*.

Cookie — small strings of text sent to and stored on your computer or mobile device (tablet or smartphone) by the *Site* and internet browser being used by *You* to access the *Site*.

Cookie Policy — the document specifying how VAIN VILLAIN deals with *Cookies*.

Data — any piece of audible, visual, textual or numerical information, all of which relevant or applicable within the context of the definition's use; this includes but is not limited to: *Personal Data*, a Proprietary Work, code, program, piece of software, link, file, photo, picture, image, text, comment, quote, lyric, description, article, post, document, *Product*, price, promotion, sale, offer, care instruction, washing instruction, quantity, color, shape, arrangement of elements or any other piece of (digital) information or material.

Data Controller — the individual or legal person responsible for using and storing *Data*.

Order — (the contents of) the *Order Summary*, whether in a state of submission by the *Client* or receipt, acknowledgement, assimilation or fulfillment by VAIN VILLAIN.

Ordering — process of submitting to VAIN VILLAIN an *Order* through the *Site*.

Order Summary — the (digital) form, containing a *Client's Personal Data*, the selected *Product Configurations*, *Client's* selection of *Courier* and *Payment Method*, any additional comments (information) provided by *Client's*, *Client's* explicit acceptance of the *Terms & Conditions* and *Client's* formal request that it desires to purchase the selected configuration of the *Products*.

Personal Data — information facilitating the identification of a natural person; this includes but is not limited to: the natural person's first name, last name, age, gender, race, religious beliefs, physical appearance (i.e. eye color, hair color, hair texture, skin color, length, weight or other body measurements), place of birth, residential address, work address, telephone number, mobile phone number, email address, fingerprint, DNA, etc....

Product — tangible object produced by VAIN VILLAIN's business operations which VAIN VILLAIN sells through the *Site*.

Privacy Policy — this document and its contents, which specifying how VAIN VILLAIN deals with privacy.

Site — the website owned, operated and managed by VAIN VILLAIN with the domain name vainvillain.com.

Site Data — any *Data* submitted and published to the *Site* by VAIN VILLAIN, the *Client* or any other person.

TYPE OF DATA COLLECTED

Personal Data of the User

PURPOSE OF THE DATA COLLECTION

- To fulfill legal and administrative obligations:

Personal Data provided by *User* will be used to manage any contractual agreements between *User* and VAIN VILLAIN established during use of the *Site* or the purchasing of *Products*. *Personal Data* will also be used for administrative purposes in connection with the fulfillment of the relevant contractual obligations or any requirements imposed by the law (e.g. accounting, tax), or for complying with any other requests from judicial authorities. VAIN VILLAIN is required to store *Your Personal Data* for the timeframe necessary to fulfill all the obligations imposed on it by the law.

- To send periodic emails:
